#### Legally blind student is first in Lee County to earn GED

Eduardo Limonta is a client of the Lighthouse of SWFL, a graduate of the Florida School for the Deaf and Blind, a student at Florida Southwestern State College and the first blind person in Lee County to earn a GED or High School Equivalency Diploma.

Limonta needed to achieve the GED to go onto higher education because colleges do not accept the diplomas awarded by the School for the Deaf and the Blind because the curriculums are different from a public or private high school that require a core base of knowledge. So with the encouragement of family and friends and assistance from Maria Durrance with the Lee County School System he studied math, science, social studies a language arts in preparation for the exam.

In January 2014, Florida went paperless for the test and introduced a computerized web based version. Fortunately for Limonta computer skills and new technologies are being emphasized in schools and centers such as the Lighthouse because of the many applications and advances that have been made to assist the visually impaired and the blind. After earning his GED, Limonta was accepted at Florida Southwestern State College and started classes in January.
